- Starting new resident survey at this month's new resident orientation to evaluate orientation session
- Some board members suggested waiting until after applicant is accepted before asking them questions about volunteering, etc. → don't want applicants to feel like they are getting screened
- Suggestion to re-survey people at annual meeting about volunteering
- Need 2-3 board members and/or ward reps at each new resident reception to recruit for board membership
- Board members to please help promote International Women's Day

Scott Creer, UM Liaison; Monthly update:

- Housing and Residential Life sponsors a survey every 2-3 years of people living in graduate student housing
- Survey gives snapshot of who people live with, where people live
- 16,738 graduate students, 959 did completed responses; 70% rent
- Reasoning for why those who rent choose not to live at CTC or Como Student Housing >> primary reasons based on unawareness of existence or misinformation (believing CTC doesn't rent to single people)

Review the Bylaw changes:

- Like changes Donna made, but she did not always seem to understand our reasoning behind why changes were made
- Concerns about language surrounding board meeting policy → Ryan will talk with Kris and check with Donna about this
- Board will approve via e-mail after Ryan meets with Kris
