Cooperative Acknowledgment

Academic Eligibility

One individual in each CTC household must meet academic guidelines during two consecutive semesters of each academic year. Undergraduates need to be enrolled for a minimum of (9) credits per semester. Graduate students are required to take at least (6) credits per semester or be actively working on a thesis project.

All eligibility requirements must be met by the date you move into CTC. Students may reside in University –owned housing for a maximum of seven years. All students will be verified by roster submitted to the University of Minnesota. If you are a graduate student who is carrying less than six credits, you must provide CTC with your advisor's name and mailing address. You need not meet eligibility requirements to apply, however you must meet them all when you move in.

Eligibility Requirements

Only University of Minnesota students and their families that meet these guidelines are eligible for CTC.

All documentation is required for each family situation upon move-in

- Graduate level student and spouse/domestic partner; single with or without children
- Undergraduate students and spouse/domestic partner, single with or without children (single undergraduates must be at Junior or Senior Level.
- Postdoctoral Fellow (9560) or Associate (9546) family or single

Extended family members are welcome for an additional \$40 per occupant per month and CTC registration. CTC pet policy prohibits dogs. Cats, fish and small birds are welcome. (Please request Pet Policy for more details.)

Applying for CTC

Due to the popularity of quality student family affordable cooperative living, CTC maintains a waiting list. To apply, complete the application and submit the \$40 application fee to activate placement on the waiting list. Upon receiving the completed application, it is dated and placed in chronological order on the appropriate list (you may apply for **ONE APARTMENT SIZE ONLY**). Specific time on the waiting list is dependent upon season and apartment size. Unfortunately, it is not possible to give specific predictions as to when a unit will be offered. CTC offers a 30-60 day notification of availability to applicants which vary at any time throughout the month.

Upon acceptance of an apartment offer, a prelease security deposit equal to one month's rent is due shortly thereafter. Apartment rental charges are effective from move-in assignment date by CTC.
