# Where We Are Now:

Investment Policy Statement (IPS) Review (First Time Since 2010)

- 1. Reviewing mission- aligned investing, including incorporating ESG principles;
- 2. Determining investment objectives, including utilizing CPA Foundation and other resources to guide the determination of objectives and avoiding direct investing;
- 3. Discussing how to structure asset allocation and other sections within IPS editing;
- 4. Describing how investment performance would be optimized and contextualized via a preference for more positive, general versus less negative, absolutist criteria.



There also will be metrics for financial performance and impact investing to be considered.

Investment portfolio update-

Recent U.S. stock market volatility during the past 1-2 months has lead to a 0.3% decrease in value across investment accounts, but projections remain for increased value as the stock market stabilizes.

Questions and next steps

After broad Board discussion, a de facto consensus emerges for Paul and the Finance Committee with invited Board members to dedicate one meeting towards reviewing and editing a 2018 IPS, with considerable updates from the 2010 IPS. From there, the rest of the Board will review the work of the Committee, offering recommendations and final edits.

A general timeline of the 2918 IPS drafting will include the Finance Committee meeting in April-May 2018, with Board recommendations to the Committee's IPS draft between May-June 2018, and final approval of the 2018 IPS by July 1, 2018.
