Capital Projects

FY18:

- 2 Bedroom Split Bldg Study \$75K Report is being reviewed
- Replace Gas Lines Between Blgs \$350K Out for Bid for Construction Services
- Replace Electrical System Construction Phase Starting Soon
- Replace Ph. IV Roofs \$600K Construction Phase Starting Soon

FY19:

• Replace Fifield Street - \$600K – Likely will start spring 2019



- Replace electrical system transformers \$700K part of the project in FY18
- Replace Community Center HVAC \$450K unknown

Other Items

Occupancy Limits – Currently in discussions with Coop attorney regarding amendment.

Safety of Minors Policy – It is very important that CTC never holds events intended for unaccompanied minors.

Strategic plan summary: facilities master plan has designated CTC land as housing for the next 30+. There is untested opportunity on the South end of site with the conjunction with housing.

ISSS connection- Scott will provide ISSS Housing coordinator information so we can make connection for their portfolio. He will reach out to see what is currently being articulated to incoming international students.

Disconnect with Departments/ University and what housing options are (aka. CTC). Internally in HRL looking to see who the connections are in each department.

Service animal training facility behind Baily Hall. Part of LLC partnered with animal training service (K9 Canines).
